**JOINT MOTION FOR STATUS
CONFERENCE**

Plaintiff Beth Andrew-Berry and Defendants George A. Weiss and GWA, LLC, respectfully request that this Honorable Court schedule a status conference so that any outstanding issues relating to the parties' pending Joint Consent to Magistrate Judge Jurisdiction (ECF 56) ("Joint Consent") may be addressed. The Joint Consent relates to Plaintiff's pending unopposed motion for preliminary approval of class action settlement, filed September 27, 2024 (ECF No. 50), and Plaintiff's forthcoming motions for final approval and for attorneys' fees and costs. *See* ECF 56.

By way of background, one of the defendants in this action—GWA, LLC—has filed for bankruptcy protection in the S.D.N.Y. bankruptcy court. The proposed class settlement would resolve the claims against GWA, LLC but must be finally approved by this court *before* the Class could release their claims in the bankruptcy proceeding. If the Court has any questions that bear upon the pending Joint Consent to refer settlement proceedings to Magistrate Judge Spector, the parties would be happy to discuss any issues at the requested status conference.
